OS2 instrument shall not terminate on said date or time limitation but shall remain in full force and effect for so long as I am militarily designated as "missing in action," or "captured," or a "prisoner of war," it being the intentment hereof that such designations of my status shall not bar my attorney from fully and completely exercising and continuing to exercise any and all rights and powers herein granted; and I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding on myself, and my heirs, legal and personal representatives, and assigns whether the same shall have been done before or after my death, unless and until reliable intelligence or notice thereof shall have been received by my said attorney.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter and thing whatsoever in and about my estate, property, and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present, the above specially enumerated powers being in aid and exemplification of the full, complete, and general power herein granted and not in limitation or definition thereof; and hereby ratifying all that my said attorney shall lawfully do or cause to be done by virtue of these presents.
