This request is for a Conditional Use Permit under Klamath County Ordinance 48 to create a non-farm parcel on land classified as agricultural. The Planning Commission reviewed the request at 5 a hearing on September 28, 1982, and recommended approval to the 6 Board of County Commissioners. The application was reviewed by 7 the Board of County Commissioners on November 23, 1982. Based on 8 the record of the hearing below, the Board of County Commissioners 9 12 makes the following Findings of Fact and Conclusions of Law: 10 811

The property in question is 7.5 acres in size and FINDINGS OF FACT: lies in a portion of Section 11 and 12 of Township 40, Range 11, 13 14

15 being Tax Lots 7-3 and 7-2-1. 2. The 7.5 acres is vacant of buildings. Applicant proposes a mobile home on five acres and a house on the remaining 16 17 18

Does not materially alter the stability of the

Is situated on generally unsuitable land for the 12 production of farm crops and livestock. 13

5. Complies with other conditions as the governing 14 body of the County considers is necessary. 15

Therefore, it is hereby ordered that the property 16 described as being that portion of Sections 11 and 12, of 17 Township 40, Range 11, being Tax Lots 7-3 and 7-2-1, be granted 18 a Conditional Use Permit to allow for the partitioning of a 19 7.5 acre non-farm parcel.
