RECITALS: Louis B. Pondella , as grantor, executed and delivered to Transamerica Title Insurance Company , as trustee, for the benefit of Albert S. Bonura and Anna R. Bonura, , as beneficiary, a certain trust deed dated December 8 , 19.82 , duly recorded on December 10 , 19.81 , in the mortgage records of Klamath County, Oregon, in book/reel/volume No. M81 at page 21203 , or as fee/file/ instrument/microfilm/reception No. (indicate which). In said trust deed the real property therein and hereinafter described was conveyed by said grantor to said trustee to secure, among other things, the performance of certain obligations of the grantor to the said beneficiary.
