KNOW ALL MEN BY THESE PRESENTS, That Clara Weaver

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and quitclaim unto Asahel Henry Weaver, Hazel Clara James, Mabel Rose Greenstreet, Orval Doyle Weaver, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of the grantor's right, title and interest in that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A portion of the SE  $\frac{1}{4}$  NW  $\frac{1}{4}$  Section 2, Township 39 South, Range 9 E.W.M., more particularly described as follows: Beginning at a point on the South boundary of said SE  $\frac{1}{4}$  NW  $\frac{1}{4}$  495 feet East of the Southwest corner of said SE  $\frac{1}{4}$  NW  $\frac{1}{4}$ ; thence parallel to the West line of said SE  $\frac{1}{4}$  NW  $\frac{1}{4}$ , 720 feet to the Southwest corner of the tract herein conveyed, being the place of beginning of this description; thence from said place of beginning East and parallel to the North line of said SE  $\frac{1}{4}$  NW  $\frac{1}{4}$ , 165 feet; thence North and parallel to the West line of said SE  $\frac{1}{4}$ , 100 feet; thence West and parallel to the North line of said SE  $\frac{1}{4}$  NW  $\frac{1}{4}$ , 165 feet; thence South and parallel to the West line of said SE  $\frac{1}{4}$  NW  $\frac{1}{4}$ , 100 feet to the point of beginning, less road described Deed Vol. 351, page 629, all being in Klamath County, Oregon.
