hereinafter known as grantors, for the consideration hereinafter stated have bargained and sold, and by these presents do grant, bargain, sell and convey unto MICKEY CUMMINGS and ESTER CUMMINGS,

husband and wife, grantees, the following described premises, situated in Klamath County, Oregon, to-wit:

A tract situated in the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 23, Township 39 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at the Southwest corner of the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of Section 23, T. 39 S., R. 9 E.W.M., in Klamath County, Oregon, which point of beginning is marked by the intersection of old fence lines with the centerline of the Homedale-Dixon County Road; thence North along the centerline of said County Road a distance of 145 feet; thence North 89°47' East, along a line parallel to and 145 feet distant from the South line of the NE $\frac{1}{4}$ SE $\frac{1}{4}$ of said Section 23, a distance of 300 feet; thence South 145 feet, more or less, to the South line of said NE $\frac{1}{4}$ SE $\frac{1}{4}$; thence South 89°47' West, along said South line a distance of 300 feet, more or less to the point of beginning.

SUBJECT TO: Reservations, restrictions, regulations, easements and rights of way of record and those apparent on the land; and also SUBJECT TO that certain Trust Deed and Note executed by the Grantors in favor of the United States National Bank of Oregon, an Association, recorded February 7, 1978, in Volume M78 at page 2218 of the Mortgage Records of Klamath County, Oregon, which the Grantees have assumed and agreed to pay and to hold Grantors harmless from.
