KNOW ALL MEN BY THESE PRESENTS, That Muriel L. Glidewell

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Erma L. Huebner, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Tract No. 23 of Violsmeier Acre Tracts, according to the official plat thereof on file in Klamath County, Oregon, Reserving unto Muriel L. Glidewell, the grantor, a life estate in said property

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except, current and accumulated taxes, easements and rights of way of record and apparent on the land, reservations and building restrictions of record, contracts and liens for irrigation and drainage and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
