

MODIFICATION OF MORTGAGE OR TRUST DEED

by and between

THIS AGREEMENT, made and entered into this <u>15th</u> day of <u>December</u> FRANCIS D. BROWN & SON, INC., a corporation

hereinafter called the "Borrower(s)" and WESTERN BANK, an Oregon banking corporation, hereinafter called the "Bank":

WITNESSETH: On or about the <u>29th</u> day of March . 19 82 , the Borrower(s) (or the original maker(s) if the Borrower is an assignee of record) did make, execute and deliver to the Bank that certain promissory note in the sum of \$_25,000.00 ____, payable in machine with interest at the rate of 18.50 % per annum. For the purpose of securing the payment of said promissory note, the Borrower(s) (or the original maker(s) if the Borrower is an assignee of record) did make, execute and deliver to the Bank their certain Mortgage or Trust Deed, hereinafter called a "Security Instrument" bearing date of <u>March 29</u>, 19 82, conveying the following described real property, situate in the County of <u>Klamath</u>, State of <u>Oregon</u> to wit: <u>PARCEL 1</u>: A tract of land situated in the SW4 of the NW4 of Section 8, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows: Beginning at a point on the Southeasterly right of way line of the Weed-Klamath Falls Highway, which point is North 44° 50½' East a distance of 138 feet from the intersection of the Southeasterly line of said Highway with the Westerly line of Section 8, and the true point of beginning; thence continuing North 44° 501/2' East along said Southeasterly line a distance of 300 feet, thence North 45° 0912' West a distance of 20 feet; thence North 44° 50¹/₂' East along aforementioned highway right of way line a distance of 50 feet; thence South 45° 09¹/₂' East at right angles a distance of 320 feet; thence South 44° 09¹/₂' West parallel to said highway line a distance of 350 feet; thence North 450 0912' West 300 feet to the point of beginning. which Security Instrument was duly recorded in the records of said county and state.

There is now due and owing upon the promissory note aforesaid, the principal sum of <u>Twenty Five Thousand</u> and no/100ths-----DOLLARS (\$ 25,000.00 ______), together with the accrued interest thereon, and the Borrower(s) desire a modification of the terms of payment thereof, to which the Bank is agreeable on the terms and conditions hereinafter stated and not otherwise.

NOW THEREFORE, in consideration of the premises and of the promises and agreements hereinafter contained, the parties hereto do hereby agree that the balance now due and owing on the promissory note hereinabove described shall be and is payable in moments of <u>Twenty Five Thousand and no/100ths</u> DOLLARS (\$25,000.00) each, plus monthly interest on the unpaid balance at the rate of *13.50% per annum. The first installment shall be and is payable on the <u>25th</u> day of <u>January</u> 19_83, and a like installment shall be and is payable on the <u>25th</u> day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and installments or either principal or interest are not so paid, the entire balance then owing shall, at the option of the Bank or its successors in interest, become immediately due and payable without notice. *Prime + 2.00% adjusted on the 25th day of each mo. beginning 12-25-82

Except as herein modified in the manner and on the terms and conditions herein stated, the said promissory note and Security Instrument shall be in full force and effect, with all the terms and conditions of which the Borrower(s) do agree to comply in the same manner and to the same extent as though the provisions thereof were in all respects incorporated herein and made a part of this agreement.
