WHEREAS, 71 property owners and registered voters have petitioned the Board of Directors of the South Suburban Sanitary District for annexation of the Skyline View/Piedmont Heights area, hereinafter more particularly described, to the South Suburban Sanitary District, Klamath County, Oregon; and

WHEREAS, said petitions have been signed within sixty (60) days of this Resolution, and the Skyline View/Piedmont Heights area is contiguous to the boundaries of the South Suburban Sanitary District.

NOW THEREFORE, BE IT RESOLVED:

1. That the Board of Directors of the South Suburban Sanitary District do hereby initiate proceedings for the annexation of the Skyline View/Piedmont Heights area, more particularly described as follows:

Beginning at the quarter corner common to Section 1, Township 39 south, Range 9 east of the Willamette meridian and Section 6, Township 39 south, Range 10 east of the Willamette meridian, all in Klamath County, Oregon, thence west 1320 feet, more or less, to the southwest corner of the southwest quarter of the southeast quarter of the northeast quarter, Section 1, thence southerly along the 1/16th Section line to a point that is 300.00 feet, more or less, north of the south line of Section 1, thence easterly parallel to the south line of Section 1, and Section 6, to a point that is 400.00 feet east of the west line of Section 6, thence northerly parallel to and 400.00 feet east of the west line of Section 6 to its intersection with the north line of the southwest quarter of the southwest quarter of said section 6, said point also being on the south boundary of "Skyline View subdivision", thence easterly along the south boundary of said subdivision to the southeast corner of said subdivision, thence northwesterly the following two courses along the easterly boundary of said subdivision: north 32° 59' west, 1181.2 feet, north 63° 3' west, 736.5 feet to the point of beginning.

TO THE SOUTH SUBURBAN SANITARY DISTRICT, KLAMATH COUNTY, OREGON.

2. That this Resolution be filed with the Board of Commissioners of Klamath County, Oregon and the Board of Commissioners of Klamath County, Oregon is hereby requested to conduct proceedings pursuant

to ORS 198.835 to 198.845 and to set a date, time and place for a public hearing on the proposed annexation as provided by law. 476

3. That the Board of Directors of the South Suburban Sanitary District approves said annexation.
