2. The personal representative has administered the est-  
ate with funds formerly held in joint accounts with the decedent  
and she did not, during the course of probate, receive on decedent's  
account any funds for which an accounting is now due. All obliga-  
tions of the decedent have been satisfied and no claims have been  
presented to the estate and there are no accounts owing, and the  
personal representative shall assume and pay from her own funds all  
remaining costs of administration, including the fee and costs of  
her attorneys.
