THIS MATTER having come before the Court on the 44th day of June, 1982, Petitioner, CLAUDIA H. LEMICH, appearing by and through THOMAS F. DELLA-ROSE of Aspell and Della-Rose, her Attorneys, who presented her Affidavit in lieu of her personal appearance, and Respondent, JOSEPH LEMICH, appearing not, and the Court finding generally that there are irreconcilable differences between the parties which have caused an irremediable breakdown of the marriage, and the Court being fully advised in the premises, now, therefore,

IT IS HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

1. The marriage of the Petitioner and Respondent is dissolved and that dissolution is finally effective on the 21st day of July, 1982;

2. Petitioner is awarded personal property as follows:

- a. The 1976 Matador automobile, Oregon license No. BKY670, VIN No. A5A167N168371;
- b. The 1962 Ford Thunderbird, California license No.

2 c. All the household furnishings, clothing, personal
3 effects and belongings, and other property in Petitioner's pos-
4 session at the time of the Decree;

5 d. All cash and bank accounts in Petitioner's posses-
6 sion at the time of the Decree;

7 e. All personal property of Petitioner's children;

8 3. Respondent is awarded personal property as follows:

9 a. The 1952 Chevrolet pickup truck, VIN No. AKCA 3080267;

10 b. The 1965 Ford Thunderbird, VIN No. 5483Z107337;

11 c. The boat and motor;

12 d. All cash and bank accounts in Respondent's posses-
13 sion at the time of the Decree;

14 e. All household furnishings, clothing, personal ef-
15 fects, and belongings in Respondent's possession at the time of
16 the Decree;

17 4. That Petitioner and Respondent are awarded a one-half in-
18 terest to each in the Vendor's interest in certain real property
19 described as Lot 229 of Tract 13589 in the County of Los Angeles,
20 California; that the proceeds therefrom shall be divided equally
21 between Petitioner and Respondent;

22 5. Respondent is awarded the real property located at 4705
23 Villa Drive, Klamath Falls, Klamath County, Oregon, and more par-
24 ticularly described as Lot 5, Block 12, Tract No. 1026, THE MEA-
25 DOWS, subject to the encumbrance thereon, which Respondent shall
26 assume and pay, holding Petitioner harmless therefrom;

1 6. Respondent is awarded the real property located at 14311
 2 Friar Street, Van Nuys, California, subject to the encumbrance
 3 thereon, which Respondent shall assume and pay, holding Petitioner
 4 harmless therefrom;

5 7. Respondent shall assume and pay the following debts and
 6 liabilities of the parties:

7 a. The account at Montgomery Ward;

8 b. The account at Town and Country Jewelers, Klamath
 9 Falls, Oregon;

10 8. Petitioner shall assume and pay the following debts and
 11 liabilities of the parties:

12 a. The United States Bank loan for sewing machine;

13 b. The account at Sears, No. 9-817458-35616-0;

14 IT IS FURTHER DECREED that THOMAS F. DELLA-ROSE, Aspell and
 15 Della-Rose, Attorneys at Law, and MICHAEL C. MILLER, Attorney at
 16 Law, are hereby discharged as Attorneys of Record.

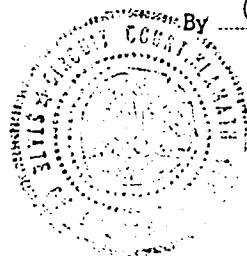
