## DESCRIPTION OF PROPOSED KLAMATH COUNTY FIRE DISTRICT NO. 7

County of Klamath ) ss.I, Edward H. Little, certify that the following is a description of the boundaries of the proposed Klamath County Fire District No. 7, to-wit:

A tract of land situated in Sections 1 thru 11 inclusive, all in T. 36 S., Range 11 E.W.M., and Sections 1, 2, 11 and 12, T. 36 S., Range 10 E.W.M., all in Klamath County, Oregon and being more particularly described as follows:

N. 57° 06' 46" W. 400.00 feet; S. 32° 53' 14" W. 80.00 feet; thence on the arc of a 50-foot radius curve (delta is 143° 07' 48") to the right 124.90 feet; N. 89° 21' 22" W. 664.76 feet; S. 57° 36' 26" W. 199.72 feet; S. 63° 43' 18" W. 199.72 feet; S. 68° 23' 54" W. 105.83 feet; West 191.03 feet to a point on the west line of Government Lot 9, in said Section 9; thence northerly along Government lot lines to the northwest corner of Government Lot 1, said Section 9; thence westerly along the north line of said Section 9 to the north 1/4 corner of said Section 9; thence southerly along Government lot lines and east line of "Nimrod River Park" to the southeast corner of said subdivision; thence westerly along the southerly line of "Nimrod River Park" to the southwest corner of said subdivision; thence northerly along the west line of said subdivision and Government Lot 12 of said Section 9 to the southeast corner of Government Lot 8 in said Section 8; thence westerly along the southerly line of Government Lots 8, 7, 6 and 5 in said Section 8 to the southwest corner of Government Lot 5 in said Section 8; thence northerly along the west line of said Section 8 to the northwest corner of said Section 7; thence westerly along the north line of said Section 7 to the northwest corner of Government Lot 1 in said Government Lots 2, 7 and 10 of said Section 7 to the northeast corner of First Addition to "Nimrod River Park"; thence southerly and westerly along the easterly and southerly boundary of said First Addition to "Nimrod River Park" to the northeast corner of Lot 6, Block 4 of said subdivision; thence westerly along the north line of said Lot 6 to the southeast corner of Lot 5, Block 4, of said subdivision; thence northerly along the east line of said Lot 5 to the northeast corner thereof; thence westerly along the north line of said Lot 5 and said line extended to the east line of Lot 27, Block 3 of said subdivision; thence northerly along said east line to the northeast corner of said Lot 27; thence westerly along the north lines of Lots 27 to 18 inclusive, Block 3 of said subdivision to the northwest corner of said Lot 18; thence southerly along the west line of said Lot 18 and said line extended to the north line of Lot 11, Block 5 of said subdivision; thence easterly along the north line of said Lot 11 to the northeast corner thereof; thence southerly along the east line of said Lot 11 to the southeast corner thereof; thence westerly along the south line of said subdivision to the southwest corner thereof; thence southerly along the west line of said Section 7 to the northerly bank of Sprague River; thence westerly along the northerly bank of Sprague River to a point on the west line of Section

12, T. 36 S., Range 10 E.W.M.; thence northerly along said west line to the west 1/4 corner of said Section 12; thence westerly along the south line of the NE 1/4 of said Section 11 to the southwest corner thereof; thence northerly along the west line of the NE 1/4 of said Section 11 to the top lip of Knot Table land; thence westerly, northerly and easterly along the top lip of said Knot Table land to the point of intersection with the east line of Section 1, T. 36 S., Range 10 E.W.M.; thence southerly along the east line of said Section 1 to the northwest corner of Government Lot 7 of Section 6, T. 36 S., Range 11 E.W.M.; thence easterly along the legal subdivision of Section lines to the northeast corner of the SW 1/4 SE 1/4 of said Section 4; thence northerly along the west line of the NE 1/4 SE 1/4 and the SW 1/4 SE 1/4 NE 1/4 of said Section 4 to the northwest corner of the SW 1/4 SE 1/4 NE 1/4 of said Section 4; thence easterly along the north line of the said SW 1/4 SE 1/4 NE 1/4 of said Section 4 to the northeast corner thereof; thence northerly along the west line of the NE 1/4 SE 1/4 NE 1/4 of said Section 4 to the northwest corner thereof; thence easterly along the northerly line of the said NE 1/4 SE 1/4 NE 1/4 of said Section 4 to the northeast corner thereof; thence northerly along the west line of said Section 3 to the northwest corner thereof; thence easterly along the north line of the NW 1/4 of said Section 3 to the northeast corner thereof; thence southerly along the east line of the NW 1/4 of said Section 3 to the northwest corner of the SW 1/4 SW 1/4 NE 1/4 of said Section 3; thence easterly along the north line of the SW 1/4 SW 1/4 NE 1/4 of said Section 3 to the northeast corner thereof; thence southerly along east line of the SW 1/4 SW 1/4 NE 1/4 of said Section 3 to the southeast corner thereof; thence easterly along the legal subdivision of Section lines to the southwest corner of the SE 1/4 SE 1/4 NE 1/4 of said Section 2; thence northerly on the west line of the SE 1/4 SE 1/4 NE 1/4 of said Section 2 to the northwest corner thereof; thence easterly on the north line of the SE 1/4 SE 1/4 NE 1/4 of said Section 2 to the northeast corner thereof; thence easterly on the north line of the SW 1/4 SW 1/4 NW 1/4 of Section 1, T. 36 S., Range 11 E.W.M. to the northeast corner thereof; thence northerly along the east line of the NW 1/4 SW 1/4 NW 1/4 and W 1/2 of Government Lot 4 in said Section 1 to the northeast corner of the W 1/2 of said Government Lot 4; thence easterly on the north line of said Section 1 to the point of beginning.

SAVING AND EXCEPTING from the above-described lands the E 1/2 SW 1/4 SE 1/4 NE 1/4 and the W 1/2 SE 1/4 SE 1/4 NE 1/4 of Section 1, T. 36 S., Range 10 E.W.M., the County Road designated as Drew's Ranch Road, and the County Road designated as Knot Table Land Road in Sections 1, 11 and 12, T. 36 S., Range 10 E.W.M.
