AGREEMENT FOR DEED IN LIEU OF FORECLOSURE

THIS AGREEMENT made this 2th day of February, 1983, by and between BERT H. GOFF and MARGERY V. GOFF, husband and wife, hereinafter called "Goff", and BOB L. AZEVEDO and DOROTHY L. AZEVEDO, husband and wife, hereinafter called "Azevedo",

WITNESSETH:

WHEREAS, Azevedo purchased from Goff under land sale contract certain real and personal property situated in the County of Klamath, State of Oregon, and,

WHEREAS, Azevedo depended upon third party obligations to Azevedo in order to make the payments to Goff, and,

WHEREAS, said third parties are in default and Azevedo is unable to fulfill their committments to Goff; now, therefore, IT IS HEREBY MUTUALLY UNDERSTOOD AND AGREED as follows:

(1) Azevedo has executed a deed in lieu of foreclosure and delivered said deed to Goff contemporaneously with the execution of this agreement, receipt of which deed Goff hereby acknowledges.

(2) By execution of this agreement and contemporaneous receipt of the above-referenced deed, Goff hereby releases Azevedo of all duties, obligations, and liabilities imposed upon Azevedo by the execution of the earnest money agreement, contract of sale of real property, and memorandum of contract by and between Goff and Azevedo.

(3) In further consideration for the execution and delivery of Azevedos' deed in lieu of foreclosure, Goff agrees that Azevedo shall be allowed to remain in possession of the real property which was subject of the contract of sale herein mentioned until the 1st day of May, 1983, at which time Azevedo shall deliver up said premises to Goff.
