together with the right of ingress and egress over Grantors'adjoining lands for the purposes of this easement.

Grantor shall not erect any structures, nor plant any trees or shrubs, within the easement area which would inhibit access to said City sewer line or cause damage to it.

In the placement of the sewer line in the above described easement area, City shall restore Grantors' fences and irrigation system in as good condition as they were immediately prior to construction.

This document shall be binding upon all subsequent purchases of the above described parcel, the City, and the heirs, successors and assigns, of both.
