KNOW ALL MEN BY THESE PRESENTS, That Priscilla L. Horn

for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto

hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit: A full interest in and to the following: Lot 2 in Block 1, Homeland Tracts, Klamath County, Oregon, EXCEPT the South 200 Feet of said lot. ALSO EXCEPTING THEREFROM the State of Oregon by and through its State Highway Commission recorded February 23, 1967, in Book M-67 at page 1250. Subject to: Regulations, including levies, assessments, water and irrigation rights and easements for ditches and canals, of Enterprise Irrigation District; Regulations, including levies, liens, assessments, rights of way and easements of the South Suburban Sanitary District; Restrictions, but omitting restrictions, if any, based on race, color, religion or national origin as shown on the recorded plat of Homeland Tracts; Reservations and restrictions contained in deed recorded September 22, 1947, in Volume 211 at page 416, Deed Records of Klamath County, Oregon; Limited access in deed to State of Oregon by and through its State Highway Commission recorded Feb. 23, 1967, in Book M-67 at page 1250 Microfilm Records; Easements and rights of way of record and those apparent on the land, if any.

This true and actual property transaction deeds said property to Lillian V. Reed in payment of debts owed to her by the grantor.
