ADDENDUM

Buyer to retain option to pay remaining principal balance off within the first two years at a price equivalent to an investment yield of $15\frac{1}{20}$. After the first two years, Buyer may buy remaining balance of note at a price equivalent to an investment yield of 18%. The Investment Yield is to be determined by that amount of money an investor is willing to offer or that amount of money a lender is willing to lend on a monthly cash flow of \$125.45 for a specific period of time in order to achieve either a $15\frac{1}{2}\%$ or a 18% per annum return on a fully amortized debt.
