Anousand Nine Hundred Fourteen and 16/100ths----- DOLLARS (\$ 228,914.16 together with the accrued interest thereon, and the Borrower(s) desire a modification of the terms of payment thereof, to which the Bank is agreeable on the terms and conditions hereinafter stated and not otherwise.

NOW THEREFORE, in consideration of the premises and of the promises and agreements hereinafter contained, the parties hereto do hereby, agree that the balance now due and owing on the promissory note hereinabove described shall be and is payable in monthly installments of Six Thousand Four Hundred Forty and no/100ths--DOLLARS (\$ <u>6,440.00</u>) each, <u>including</u> interest on t per annum. The first installment shall be and is payable on the <u>25th</u> day of DOLLARS (\$ 6,440.00 interest on the unpaid balance at the rate of 12.50*%. 19<u>83</u>, and a July paid, except that the final payment of principal and interest if not sooner paid, shall be due and payable on the <u>25th</u> day of <u>August</u>. <u>19</u>. <u>87</u>.
