CONSENT AGREEMENT

- 4. Grantee shall indemnify and hold harmless the Grantor against all claims or liabilities for damage to life or property arising from Grantee's acts or omissions in the installation, operation, and maintenance of said telephone cable and appurtenances.
- 5. This Consent Agreement is issued on the condition that the Grantee has secured, or will secure, the consent of any person having claim to the land.
