

CONSENT AGREEMENT

WHEREAS the United States of America, hereinafter called the Grantor, has an interest in the real property hereinafter described by virtue of a right-of-way easement deed dated March 17, 1979 and recorded in the records of Klamath County Oregon the 2nd day of May, 1979 in Volume M-79, Page 9887, and which easement traverses the following described real property in the County of Klamath, State of Oregon to wit:

T. 32 S., R. 8 E., W.M.

Section 28, S1/2SW1/4

WHEREAS, Telephone Utilities of Eastern Oregon, Inc., hereinafter called the Grantee, has need to install, operate, and maintain an underground telephone cable and the necessary appurtenances thereto within the Grantor's easement.

NOW THEREFORE, the Grantor consents to the installation, operation, and maintenance of said cable and appurtenances within the Grantor's easement subject to the following conditions:

1. Installation will be in accordance with construction drawings submitted to and on file with Grantor in Klamath Falls, Oregon.
2. The Grantee shall repair all damage to National Forest roads caused by the Grantee's acts or omissions in exercise of the rights granted herein.
3. In the event that future exercise of the Grantor's rights require relocation of the Grantee's improvements, such relocation will be done at the Grantee's expense.
4. Grantee shall indemnify and hold harmless the Grantor against all claims or liabilities for damage to life or property arising from Grantee's acts or omissions in the installation, operation, and maintenance of said telephone cable and appurtenances.
5. This Consent Agreement is issued on the condition that the Grantee has secured, or will secure, the consent of any person having claim to the land.

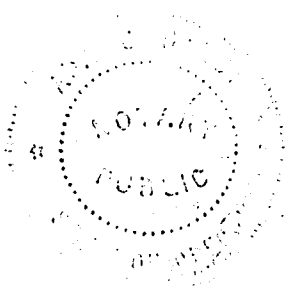
