KINNAN and/or LOUISE E. KINNAN, husband and wife,

of the County of Klamath, State of Oregon, the following described premises situated in Klamath County, State of Oregon, to-wit:

Lot 27, Block 3, RIVERVIEW ADDITION, in the County of Klamath, State of Oregon.

Together with the tenements, hereditaments and appurtenances thereto belonging, or in anywise appertaining. To have and to hold the same with the appurtenances, unto the said ROBERT D. KINNAN and/or LOUISE E. KINNAN, husband and wife,

heirs and assigns forever. THIS CONVEYANCE is intended as a Mortgage to secure the payment of the sum of TWENTY THOUSAND and NO/100-----Dollars (\$20,000.00) in accordance with the terms of that certain promissory note of which the following is a substantial copy:

KINNAN at 5430 Delaware Av., Klamath Falls, OR TWENTY THOUSAND and NO/100-----DOLLARS, with interest thereon at the rate of Six percent per annum from June, 1982, until paid, payable in installments of not less than \$150.00 in any one payment; the first payment to be made on the 15th day of January 1983, and a like payment on the 15th day of each month thereafter, until the whole sum, principal and interest has been paid; if any of said installments is not so paid, all principal and interest to become immediately due and collectible at the option of the holder of this note. If this note is placed in the hands of an attorney for collection, I/we promise and agree to pay holder's reasonable attorney's fees and collection costs, even though no suit or action is filed hereon; however, if a suit or an action is filed, the amount of such reasonable attorney's fees shall be fixed by the court, or courts in which the suit or action, including any appeal therein, is tried, heard or decided.
