6 This appeal for waiver of survey for Eugene Tomlin on
7 Major Partition 81-35 came on for hearing before the Planning
8 Commission with public hearing having been heard on March 22,
9 1983, wherefrom the testimony, reports and information produced
10 at the hearing by the applicant, planning staff, and other
11 persons in attendance, the Planning Commission made a motion of
12 denial of appeal.

13 The Planning Commission makes the following Findings of
14 Fact:

FINDINGS OF FACT:

15
16 1. The Planning Commission stated site for survey was
17 located in a portion of Section 9, Township 25, Range 8, being
18 Tax Lots 1400 and 1500.

19 2. It was noted that the parcel for survey was approximat-
20 ely 30 acres in size and basically rectangular in shape.

21 3. The motion was based on Public Works Department's
22 information that a registered survey would be easily obtained, to
23 get a proper and legal boundary establishment and measurement on
24 this property.

CONCLUSIONS OF LAW:

26 1. Based on the testimony and information and reports at
27 said hearing, the request for the waiver of survey of property
28 is to be denied with applicant supplying a survey on Major

1 Partition 81-35 as requested.

2 Now, therefore, it is hereby ordered that the appeal of
3 waiver of survey for Eugene Tomlin on Major Partition 81-35 for
4 the parcel of land located in a portion of Section 9, Township
5 25, Range 8, being Tax Lots 1400 and 1500, has been denied.
