GRANT OF RIGHT-OF-WAY ACCESS Easement

T. 41 S., R. 8 E. Willamette Meridian; Section 5, lots 1 and 2; the parcel being that existing road approximately 20 feet wide and approximately .9 miles long which serves as access to the S.W. corner of the SE4 of Section 32, T. 40 S. R. 8 E. Willamette Meridian.

The right-of-way is for the following purposes: the right of ingress and egress; the right to construct, reconstruct, operate, maintain, replace, grade and level a road; the right to trim, cut, fell and remove underbrush, trees and other vegetative obstructions or obstacles within the limits of the right-ofway; reserving however, to the Grantors, their heirs, executors, administrators, and successors, all rights, title, interest and privileges as may be used and enjoyed without interfering with or abridging the rights hereby acquired by the Government; the above estate is taken subject to all existing easements for roads and utilities.

It is understood by all parties that Grantors may substitute this right-of-way

with one of equal or greater utility acceptable to the United States, and that its use will be by authorized persons not the general public.
