Sirmon, Regional Forester, Forest Service, Department of Agriculture, do hereby certify that the portion of the easement over the above-described property is hereby terminated by the United States of America. The remainder of the easement granted under the aforementioned easement deed remains in full force and effect and this partial termination has no effect thereupon.

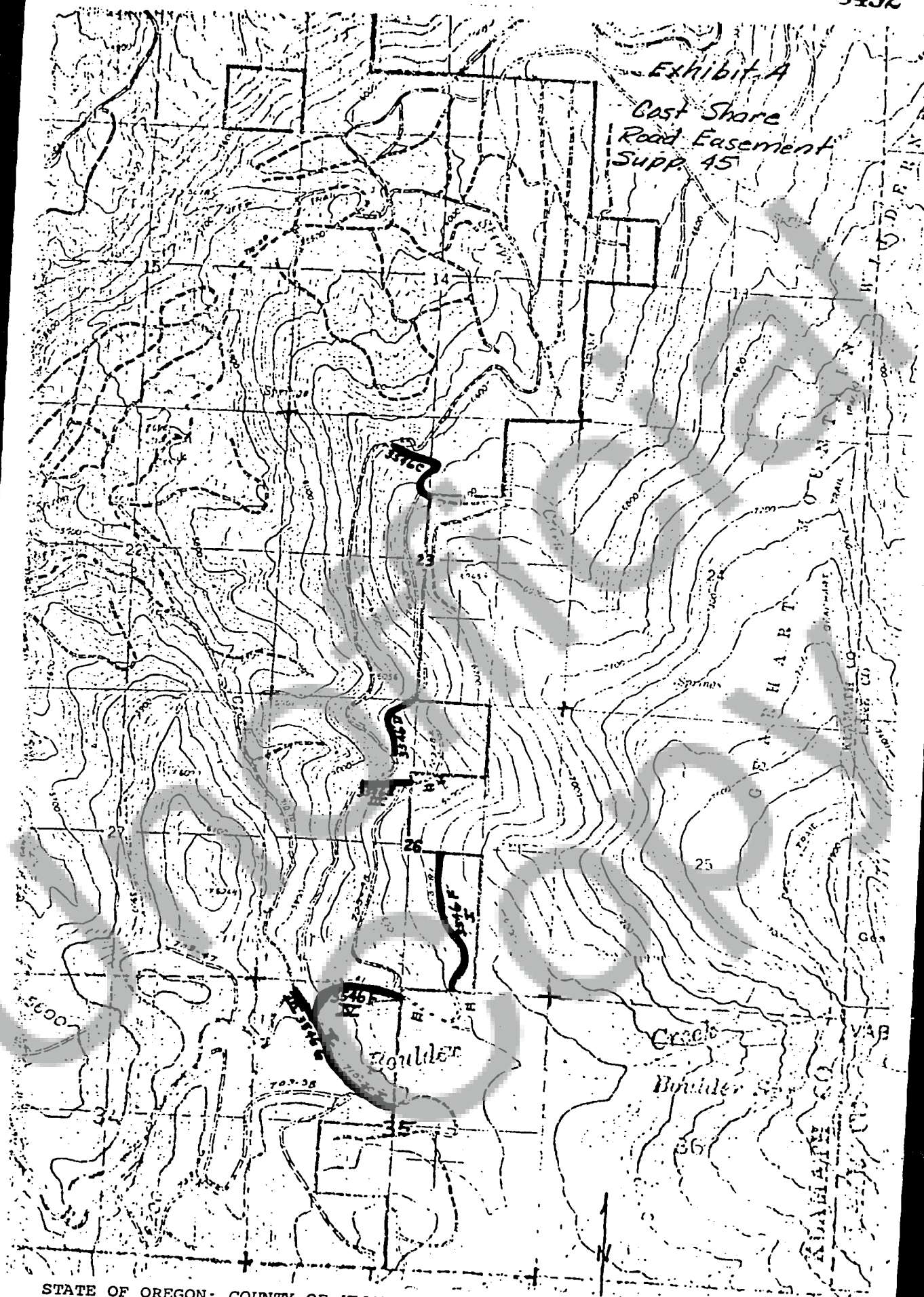
