ASSIGNMENT AND RELEASE OF MORTGAGE



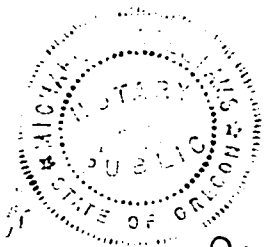
