On November 1, 1979, A. R. WOOLWORTH, PENNY M. WOOLWORTH, and RONALD A. WOOLWORTH, as Trustors, executed a Trust Deed wherein WILLIAM P. BRANDSNESS was the Trustee, and ROGER CHRYSLER, trustee for KENNETH K. MAGEE, MARY BELDGADE, SYDNEY G. CHRYSLER BALLARD, JON P. CHRYSLER, ROGER CHRYSLER and MARGARET CHRYSLER STRONG, was the Beneficiary. The Trust Deed covered real property (the "Property") in Klamath County, Oregon, and was recorded in Book M-79, Page 26439, of the Klamath County, Oregon Mortgage Records on November 9, 1979. RONALD A. WOOLWORTH, one of the Trustors, now holds fee simple title to the Property in his name alone subject only to the Trust Deed described above.

RONALD A. WOOLWORTH now wishes to borrow \$100,000 from the UNITED STATES NATIONAL BANK OF OREGON (the "Bank") and to secure that loan with a mortgage on the Property. The Bank is willing to make the loan but only if it can acquire a first lien on the Property superior in right to the lien of the Trust Deed described above.

For valuable consideration WILLIAM P. BRANDSNESS, in his capacity as Trustee as aforesaid, and ROGER CHRYSLER, trustee, in his capacity as Beneficiary as aforesaid, hereby subordinate the lien of the Trust Deed described above to the lien of a mortgage on the Property from RONALD A. WOOLWORTH to the UNITED STATES NATIONAL BANK OF OREGON dated February 3, 1983 and recorded on Mat(1, 1983), in Book M_1 , Page $24M_1$ Mortgage Records of Klamath County,

Oregon, just as though the mortgage in favor of the Bank had been properly executed by the fee simple owner of the Property and recorded prior to the recording of the Trust Deed described above, and without any actual or implied knowledge on the part of the Bank of the lien of the Trust Deed at the time of the recording of the

The signatories whose names appear below agree that the Bank's mortgage to which they are subordinating secures not only the \$100,000 debt described above but also all interest due or to become due on the note evidencing the debt plus all extensions and renewals
