AGREEMENT FOR ELECTRIC SERVICE

The undersigned, hereinafter called the Applicant, hereby applies for electric service and agrees to purchase electric from Midstate Electric Cooperative, Inc., hereinafter called the Cooperative, upon the following terms and conditions:

1. The Applicant will pay to the Cooperative the sum of \$ 45.00 which constitutes the Applicant's deposit.
2. The Applicant will, as electric energy is available, purchase from the Cooperative all electric energy used on the premises described below, and will pay, therefore, monthly in accordance with the current applicable rate schedule in accordance with the rules and regulations established by the Board of Directors of the Cooperative. The Cooperative may limit the amount of electric energy furnished for industrial purposes. The Applicant will pay a bill of at least \$ 212.00 per year.
3. The Applicant will cause his premises to be wired in accordance with wiring specifications approved by the Cooperative and in conformity with the law, National Electric Code, National Safety Code and any applicable local ordinance.
4. The Applicant, by paying a deposit fee, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative.
5. The Applicant will comply with and be bound by such rules and regulations as may be established by the Board of Directors from time to time.
6. Additional charges will be made for underground services: 35c per foot for wire only
7. This agreement is subject to the execution of all easements necessary to serve the subject property.
8. The Applicant acknowledges receipt of Cooperative hand out sheet entitled "Electric Service Requirements."
9. In the event suit or action is commenced to enforce any provision of this agreement. The prevailing shall be entitled to reasonable attorney fees and costs. This amount shall be fixed and is not related to electrical energy consumption.

The acceptance of this application by the Cooperative will constitute an agreement between the Applicant and the Cooperative, and the contract for electric service shall continue in force for five years from the date service was made available by the Cooperative to the Applicant, and thereafter until cancelled by at least thirty (30) days written notice by either party to the other party.

This contract and the obligations thereof shall run with and be binding upon the land of the undersigned in Klamath County, Oregon described as follows:

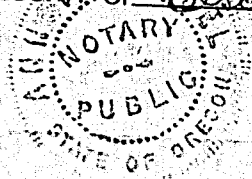
