
STATEMENT OF ACCOUNT OF



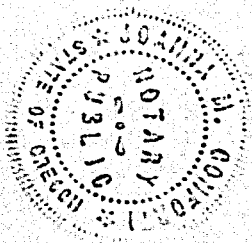
The amount received for the chattels listed on the Notice of Foreclosure Sale was \$575.00.
