I, JAMES WRIGHT, SR., of Klamath County, Oregon, being of legal age, and of sound and disposing mind and memory, and not acting under the fraud, duress or undue influence of any person whomsoever, do hereby make, publish and declare this to be my Last Will and Testament, hereby revoking all wills and codicils by me at any time heretofore made.

FIRST

I direct that my debts and funeral expenses be paid as soon after my death as may be reasonably convenient. I hereby authorize and empower my Personal Representative in case of any claim against my estate to settle and discharge the same in his or her absolute discretion.

SECOND

FOURTH

FIFTH

WRIGHT, of Bellingham, Washington, and STEWART JEFFERSON, my step-son, of Chiloquin, Oregon.

SIXTH

I hereby nominate, constitute and appoint ARTHUR A. BEDDOE, of Klamath Falls, Oregon, to be Personal Representative of this, my Last Will and Testament.

In the event that the said ARTHUR A. BEDDOE shall be unable or unwilling to serve as such Personal Representative, then and in that event, I nominate, constitute and appoint DOREEN A. BEDDOE, of Klamath Falls, Oregon, to serve as such Personal Representative.

SEVENTH

I hereby empower my said Personal Representative to lease, sell, encumber, exchange or otherwise deal with or dispose of all of my property, or any part thereof, in such a manner or upon such terms as to him or her may seem advisable. Such sale or other disposition may be without petition, citation, hearing, order, notice, bond or other intervention of any Court, and may be a public or private sale, as to my said Personal Representative may seem advisable.

EIGHTH

Although my wife, FLORENCE WRIGHT, has executed or proposes to execute a last will and testament containing substantially the same provisions as this, my Last Will and Testament, and it is the present intention of my wife and myself to make similar dispositions of our separate properties, and of any other property, inherited or otherwise obtained by one from the other, I specifically state and declare that I have not made this Will in consideration of such a will by my wife, and that any property received by her pursuant to this Will shall be hers absolutely and with freedom to dispose of the same by will or otherwise, as she shall see fit.
