hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by  
James L. Schell and Marlene L. Schell, husband and wife, hereinafter called  
the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and  
assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or ap-  
pertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 7 in Block 92 in Klamath/Forest Estates, Highway 66,  
Unit No. 4 according to the official plat thereof on file in the office  
of the County Clerk of Klamath County, Oregon.

Subject to reservations, restrictions, rights of way of record and those  
apparent upon the land; AND Trust Deed, executed by Grantors herein to  
Klamath County Title Co., Trustee for Klamath Forest Estates Unit No. 4,  
et al, as beneficiary, dated November 18, 1981, recorded December 4, 1981  
in Vol M81 page 20929, records of Klamath County, Oregon, WHICH Said trust  
deed Grantees herein DO NOT Assume, and Grantors agree to hold Grantees harm-  
less thereof.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$12,000.00
