The Grantors, Winston H. Patterson and Louise Patterson, husband and wife; James C. Ross and Marilyn J. Ross, husband and wife, for and in consideration of the sum of Five Thousand One Hundred Dollars (\$5,100.00), in hand paid by the United States of America, the receipt of which is hereby acknowledged, hereby grant, bargain, sell and convey unto the United States of America and its assigns, a perpetual easement and right-of-way approximately 20 feet in width, over and across the lands of the Grantors in Klamath County, Oregon, to wit:

A PARCEL OF LAND lying in:

T. 41 S., R. 8 E. Willamette Meridian; Section 5, ^{N $\frac{1}{2}$ NE $\frac{1}{4}$} ~~the parcel~~ being that existing road approximately 20 feet wide and approximately .9 miles long which serves as access to the S.W. corner of the SE $\frac{1}{4}$ of Section 32, T. 40 S. R. 8 E. Willamette Meridian.

The parcel described above contains approximately 2.18 acres, more or less.

The right-of-way is for the following purposes: the right of ingress and egress; the right to construct, reconstruct, operate, maintain, replace, grade and level a road; the right to trim, cut, fell and remove underbrush, trees and other vegetative obstructions or obstacles within the limits of the right-of-way; reserving however, to the Grantors, their heirs, executors, administrators, and successors, all rights, title, interest and privileges as may be used and enjoyed without interfering with or abridging the rights hereby acquired by the Government; the above estate is taken subject to all existing easements for roads and utilities.

It is understood by all parties that Grantors may substitute this right-of-way with one of equal or greater utility acceptable to the United States, and that its use will be by authorized persons not the general public.
