KNOW ALL MEN BY THESE PRESENTS: The undersigned, herein-after called the claimant, has performed labor and supplied materials actually used in production of an agricultural product known as alfalfa hay cubes, all at the instance of the owner of said cubes. The name of the owner or reputed owner of the alfalfa hay cubes and the location of its business: RON HAWKINS, ROD LYONS and JERRY DERRY, a limited partnership doing business as E-Z FEED CUBE LTD., P. O. Box 7, Malin, Oregon 97632. The name of the person who provided the labor, supplied the material and provided services is: EDMOND M. MCAULIFFE, P. O. Box 471, Malin, Oregon 97632. The kind of labor performed and materials provided was: alfalfa hay grown and produced by claimant which hay was used in the production of alfalfa hay cubes. A true statement of claimant's demand after deducting all just credits and offsets is as follows, to wit:

Claimant claims a lien for the amount last stated upon the alfalfa hay cubes produced from the hay supplied together with all proceeds from the sale of said cubes if sold. The amount claimed is a true and bona fide existing debt as of the date of filing this notice of claim of lien. The debt became due 30 days after delivery of the hay on July 14, 1983, to wit: August 14, 1983. There were no terms for extended payment.
