The said labor, materials and/or services consisted of custom harvesting, baling, and
transporting said hay.

The foregoing lien is authorized by ORS 87.226(1). ORS 87.242 provides in part:
"(1) A person claiming a lien created by ORS 87.216 to 87.232 shall file a written notice of claim of lien with the recording officer of the county in which the lien debtor resides, or, if the lien debtor is a business, the county in which the lien debtor has its principal place of business not later than 60 days after the date of the furnishing of the labor, services or materials."

ORS 87.246 provides:

"The recording officer of the county shall record the notices filed under ORS 87.242 in a book kept for that purpose and called 'index of liens upon chattels.'"

ORS 87.252 provides:

"When a lien claimant files a notice of claim of lien as required by ORS 87.242, he shall send forthwith a copy of the notice to the owner of the chattel to be charged with the lien by registered or certified mail sent to him at his last-known address."
