KNOW ALL MEN BY THESE PRESENTS, That Orville C. and Leah C. Ferrell

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Gary A. and Sue Crenshaw, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

The Easterly 32 feet of the following described parcel:  
Beginning at the Southwest corner of Tract 25 of Vicory Acres, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon; thence East along the South line of said Lot 25 to the West line of Block 3 of Casa Manana, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon; thence North along the West line of said Block 3 to the South line of Block 1 of Casa Manana; thence West along the South line of Block 1 of Casa Manana and the South line of Block 1 extended to a point on the West line of Lot 25 Vicory Acres; thence South along the West line of Vicory Acres to the point of beginning.
