ADDITIONAL TERMS 9-L

ASSIGNMENT OF TRUST DEED BY BENEFICIARY

This assignment is irrevocable for a period of 120 months beginning October 1983. At the end of said period all interest in the property shall revest in the Assignor and Assignee shall execute a document of reassignment. All costs of reassignment shall be born by Assignor herein.

Should the note referenced herein be prematurely paid in full prior to the aforesaid 120 month period, the proceeds shall be divided between the Assignor and Assignee herein named according to the table attached hereto and identified as Exhibit "A". The figure shown after the payment number (1 to 120) is the amount to be kept by Assignee if the pay off is made after the numbered payment is received and before the next numbered payment. The balance of the pay off will be paid to the Assignor, and Assignee shall reassign their interest to Assignor as above described.

In the event there is a partial pre-payment of principal on the above referenced note, the amount thereof shall be deducted from the figure shown after the payment number (1 to 120) if the partial pre-payment is made after the numbered payment and before the next numbered payment, and the table shall be accelerated to the figure closest to, but not lower than, the figure thereby derived. Assignee shall then be entitled to receive the remaining payments from the next numbered payment through payment number 120. At the end of said term, Assignee shall re-

If there is any default under the above described note and trust deed for more than 30 days after written notice to Assignor, the Assignee herein shall reassign the note and trust deed to the Assignor and the Assignor will pay the amount shown opposite the payment number as described above, plus the costs of reassignment, or, at the option of Assignee, the Assignee may declare this assignment to be a full, complete and final assignment of the note and trust deed and Assignor shall not have any further right, title or interest therein.
