that the name of the owner, or reputed owner thereof is Greg Stout Logging that Greg Stout the authorized agent of such owner, and having the lawful possession of said property, requested said service and materials; that the said labor, skill and materials were so expended and performed upon the said chattel property by claimant between the 1st day of September 1983, and the 7th day of September 1983, and the rendition and performance of said storage, labor, skill and furnishing of materials by said claimant was closed on the 20th day of September 1983; that sixty days have not elapsed since said storage, labor, skill and materials were expended on said chattel; that said chattel was delivered to said owner thereof or his duly authorized agent in Klamath County, Oregon, on September 7, 1983 and sixty days have not elapsed since that time; that the amount claimant demands for said storage, labor, skill and materials so expended and furnished is \$1,375.97; that no part thereof has been paid, except \$-0-; and there is due and remaining unpaid thereon, after deducting all just credits and offsets, the sum of \$1,383.97, and the further sum of \$500 costs for the preparation of said lien notice, (provided said lien claim has not been paid in full prior to the expiration of the time allowed by law for the filing of notice thereof). In which amount said claimant now claims a lien upon said chattel property.
