WE, the undersigned, who use the Ingress-Egress Easement recorded in Volume M83, page 17469-17472 of the Official Records of Klamath County, Oregon, wish to make a written agreement concerning the use and maintenance of this roadway.

By signing our names below, we agree to share the costs, maintenance, labor and materials on an equal basis, as needed to keep said roadway in good driveable repair.

Since this document can be expanded to include additional participants, let it be known that the Gibsons and Grows do not agree to join in any of the costs, materials, or labor involved in bringing said roadway up to County standards as will be required with the partitioning and sale of any additional real property located in the Northeast Quarter of Section 30, Township 38 South, Range 6 East, Willamette Meridian, Klamath County, Oregon.

After said required work and costs are completed, to the satisfaction of the County, the Gibsons and Grows will again join in the joint agreement to equally share the costs, maintenance, labor and materials to keep said roadway in good driveable repair.

Any and all work done to the roadway shall have full, mutual consent of all signing parties before any work starts; ←
