KNOW ALL MEN BY THESE PRESENTS, that THE REMNANT CHURCH OF INFORMED

CHRISTIANS, an Express Natural Real Individual in Law, hereinafter called the grantor/grantee, for the consideration hereinafter stated, if any, paid by THE REMNANT CHURCH OF INFORMED CHRISTIANS, an Article I church established under the Republican Constitution of the Union of the United States of America, does hereby grant, bargain, sell and/or convey unto said grantor/grantee and grantor/grantee's succession of successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the COUNTY OF KLAMATH and STATE OF OREGON, described as follows, to-wit:

To have and to Hold, by Allodium Title under Allodial conditions as in Wallace v. Harmstad, 44 Pa. 499; Barker v. Dayton, 28 Wis. 384; 1 washb. Real Prop. 16.; and McCartee v. Orphan Asylum, 9 Cow., N.Y., 511, 18 Am. Dec. 516, the same unto said grantor/grantee's succession of successors and assigns, this day, and for all time.

ALLODIUM DEFINED: Land held absolutely in one's own right, and not of any lord or superior; land not subject to fuedal duties or burdens. An estate held by absolute ownership, without recognizing any superior to whom any duty is due on account thereof.

Free; not holden of any lord or superior; owned without obligation of vassalage or fealty; the opposite of fuedal. "the means whereby the owner of land(s) has the just possession of his property". The union of all the elements which constitute ownership. (Black's Law Dictionary, Revised Fourth Edition, 1968, pages 100 and 1655.)

And said grantor/grantee hereby covenants that the above granted premises is owned free and clear, and free of all other encumbrances by virtue of Article I as hereinabove detailed, and by establishment as an Express Natural Real Individual
