NOTICE OF DEFAULT AND ELECTION TO SELL

Reference is made to that certain trust deed made by LAWRENCE S. SAMANTE, as grantor, to TRANSAMERICA TITLE INSURANCE COMPANY, as trustee, in favor of WELLS FARGO REALTY SERVICES, INC., as beneficiary, dated July 22, 1978, recorded September 19, 1978, in the mortgage records of Klamath County, Oregon, in Book XXXXXX / volume No. M-78, at page 20673, or as fee/for instrument/interior/exception No. XXXXXX (indicate which), covering the following described real property situated in said county and state, to-wit:

There is a default by the grantor or other person owing an obligation, the performance of which is secured by said trust deed, or by their successor in interest, with respect to provisions therein which authorize sale in the event of default of such provision: the default for which foreclosure is made is grantor's failure to pay when due the following sums: monthly installments of principal and interest beginning with May 17, 1983 and subsequent monthly payments of \$60.07 each due under the terms and provisions of the Note and Trust Deed.

By reason of said default, the beneficiary has declared all obligations secured by said trust deed immediately due and payable, said sums being the following, to-wit:

\$3,242.13 with interest thereon from April 17, 1983 at the rate of EIGHT (8%) per cent per annum until paid, and all sums expended by the Beneficiary pursuant to the terms and provisions of the Note and Trust Deed.

Notice hereby is given that the beneficiary and trustee, by reason of said default, have elected and do hereby elect to foreclose said trust deed by advertisement and sale pursuant to Oregon Revised Statutes Sections 86.705 to 86.795, and to cause to be sold at public auction to the highest bidder for cash the interest in the said described property which the grantor had, or had the power to convey, at the time of the execution by him of the trust deed, together with any interest the grantor or his successors in interest acquired after the execution of the trust deed, to satisfy the obligations secured by said trust deed and the expenses of the sale, including the compensations of the trustee as provided by law, and the reasonable fees of trustee's attorneys.

Said sale will be held at the hour of 10:00 o'clock, A.M., Standard Time as established by Section 187.110 of Oregon Revised Statutes on April 30, 1984, at the following place: Transamerica Title Insurance Company, 600 Main Street, in the City of Klamath Falls, County of Klamath, State of Oregon, which is the hour, date and place fixed by the trustee for said sale.
