LEGAL DESCRIPTION

All those lands situated in Township 38 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, more particularly described as follows:

Section 22:  $E\frac{1}{2}SE\frac{1}{4}$

Section 23:  $S\frac{1}{2}NW\frac{1}{4}$ ,  $SW\frac{1}{4}NE\frac{1}{4}$ ,  $S\frac{1}{2}SW\frac{1}{4}$ ,  $NW\frac{1}{4}SW\frac{1}{4}$ ,  $SE\frac{1}{4}$

Section 25:  $W\frac{1}{2}$ ,  $W\frac{1}{2}SE\frac{1}{4}$
