Raymond D. Littlehale and Gerri M. Littlehale, husband and wife, as grantor(s), executed and delivered to the Farmers Home Administration, United States Department of Agriculture, acting through the State Director of the Farmers Home Administration for the State of Oregon, as trustee, for the benefit of the United States of America, acting through the Farmers Home Administration, United States Department of Agriculture, as beneficiary, a certain trust deed dated August 29, 1978, and recorded September 19, 1978, in Volume M78, page 20722 of Mortgages, records of Klamath County, Oregon. In and by said trust deed the real property therein and hereafter described was conveyed by said grantor(s) to said trustee to secure, among other things, the performance of certain obligations of the grantor(s) to the said beneficiary as set forth in said trust deed. The mailing, service and publication of said notice of sale are shown by one or more affidavits of proofs of service duly recorded prior to the date of sale in the mortgage records of said county, said affidavits and proofs, together with the said notice of default and election to sell and the trustee's notice of sale, being now referred to and incorporated in and made a part of this trustee's deed as fully as if set out herein verbatim. On the date of said notice of sale, the undersigned trustee had no actual notice of any person, other than the persons named in said affidavits and proofs having or claiming a lien on or interest in said described real property subsequent to the interest of the trustee in the trust
