# MEMORANDUM OF COLLATERAL SHARING AGREEMENT

THIS MEMORANDUM OF COLLATERAL SHARING AGREEMENT ("Memorandum") is made as of December 15, 1983, between the CALIFORNIA ALTERNATIVE ENERGY SOURCE FINANCING AUTHORITY ("Authority") and FIRST INTERSTATE BANK OF OREGON, N.A.,

#### RECITALS:

- 1. The Authority and Bank have as of this 15th day of December, 1983, entered into that certain Collateral Sharing Agreement ("Collateral Sharing Agreement").
- 2. The Authority has as of December 15, 1983 issued certain Floating Rate Demand Cogeneration Revenue Bonds (Jeld-Wen, inc. Project) in an aggregate principal amount of \$3,100,000. ("Bonds")
- 3. The Bonds are secured by collateral, including a certain Standby Letter of Credit ("Letter of Credit") issued as of this 15th day of December, 1983, by Bank, for the account of Jeld-Wen, inc. ("Company"), and naming First Interstate Bank of Oregon, N.A., Trustee, as Beneficiary ("Trustee").
- 4. As security for the issuance of the Bonds and a Loan Agreement entered into between the Authority and the Company, and as security for the issuance of the Letter of Credit, the Company has as of this 15th day of December, 1983, granted to both Bank and the Authority security interests in and liens on certain real property and personal property (collectively "Collateral") pursuant to certain mortgages and deeds of trust entered into as of this 15th day of December, 1983. The real property covered by those mortgages and deeds of trust are located in Lassen County, California and Klamath County, Oregon, and descriptions of that real property are attached to this Memorandum as Exhibits A and B, respectively.
- 5. The Bank and the Authority have entered into the Collateral Sharing Agreement in order to agree among themselves as to the relative priority of their respective security interests in the Collateral.

NOW, THEREFORE, it is agreed as follows:

1. The Collateral Sharing Agreement, and all exhibits attached to it and made a part of it, is incorporated into this Memorandum and by this reference made a part of this Memorandum.

2. Without limiting the generality of the forego-

- (a) Subject to Bank's Prior Security Interest: (1) Bank's lien on and security interest in Collateral shall rank equally with Authority's lien on and security interest in Collateral, and (2) Authority's lien on and security interest in Collateral shall rank equally with Bank's lien on and security interest in Collateral.
- (b) Terms which are not defined in this Memorandum and are defined in the Collateral Sharing Agreethe Collateral Sharing Agreement.
- 3. The Authority has as of this 15th day of December, 1983, assigned its right, title, and interest in the Collateral Sharing Agreement to the Trustee. The Trustee executes this Memorandum as such assignee.
- 4. The Company executes this Memorandum in order to signify that it has agreed to the terms of the Collateral Sharing Agreement.

IN WITNESS WHEREOF, the Authority, Bank, the Trustee, and the Company have caused this Memorandum to be executed by their duly authorized officers as of this 15th day of December, 1983.
