Hathaway, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit: Lot 20 in Block 9, Tract 1064, First Addition to Gatewood, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Renfrow et us to William Sisemore, trustee for Klamath First Federal S/Loan dated April 2, 1979, recorded April 2, 1979 in Vol M79 page 7210, records of Klamath County, Oregon WHICH SAID Trust Deed Grantees herein agree to assume and pay according to its terms.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
