

SUPPLEMENTAL AGREEMENT

On July 20, 1982, an Easement for Buried Cable, hereinafter designated as the "Original Easement," was granted by WEYERHAEUSER COMPANY to TELEPHONE UTILITIES OF EASTERN OREGON, INC.

The parties mutually agree that the Original Easement shall be and is hereby supplemented as follows:

1. The easement is extended to include portions of the following described lands in Klamath County, Oregon:

all in Township 28 South, Range 8 East, W.M., the centerline of said easement being located approximately as shown by a red line on the attached "Exhibit A."

2. The sentence, "Subject as to said lands to all matters of public record.", is hereby deleted and replaced by the following:

Subject as to said lands to all matters of public record, including but not limited to that certain Easement Deed dated June 14, 1960 to the United States of America recorded in Volume 322 on Page 505 and that certain Easement dated May 7, 1969 to the United States of America recorded in Volume M69 on Page 4757, Records of Klamath County, Oregon.

Except as herein expressly provided, all of the terms and conditions of the Original Easement shall remain unmodified.
