

RELEASE OF JUDGMENT LIEN ON PROPERTY

WHEREAS, ALLAN C. BENSON and MELODIE C. BENSON are the owners of certain real estate in Klamath County, Oregon, described as:

Lots 3 and 4 in Block 72 of Bowne Addition to Bonanza, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

AND, WHEREAS, the UNITED STATES OF AMERICA, acting through the Farmers Home Administration, holds a first deed of trust on the above-described property to secure an indebtedness to the United States of America, which deed of trust is dated April 7, 1981, and recorded April 7, 1981 in Volume M-81 and page 6245, Mortgage Records of Klamath County, Oregon; and

WHEREAS, the amount of the indebtedness secured by the Farmers Home Administration's first deed of trust exceeds the value of the said real estate; and

WHEREAS, CENTRAL OREGON COLLECTION SERVICE has caused a judgment against Allan C. Benson and Melodie C. Benson to be entered in its favor in the amount of \$341.83, plus cost and interest, on November 9, 1982 in Judgment Lien Docket 37 on page 509, records of Klamath County, Oregon; and

WHEREAS, the above Allan C. Benson and Melodie C. Benson desire to convey and the United States of America desires to accept the above-described property in full settlement of the said indebtedness to the United States of America;

NOW, THEREFORE, in consideration of said conveyance and the request of the United States of America, Central Oregon Collection Service, releases the above-described real property from the lien of its judgment. Only the above-described real property is released from the said lien and for all other purposes the judgment of Central Oregon Collection Service, remains in effect.

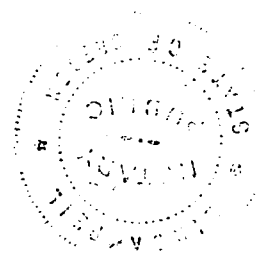
