ROAD USE AGREEMENT

THIS AGREEMENT, made and entered into this 26th day of January, 1970, by and between WEYERHAEUSER COMPANY, a Washington corporation, herein called "Grantor", and A. E. WAMPLER and MAYME WAMPLER, husband and wife, herein called "Grantees", WITNESSETH:

Grantor hereby grants unto Grantees a perpetual, nonexclusive easement to use the existing road along a right of way not exceeding 20 feet in width over Lot One (1) of Section Thirty-two (32), Township Thirty-six (36) South, Range Seven (7) East of W. M., in Klamath County, Oregon, extending from the County Road in said lot to the North line of said lot, for the purpose of access to Grantees' water pump in Lot Twelve (12) of said Section Thirty-two (32).

The Grantor reserves the right, at any and all times, and for any purpose, to go upon, cross, recross and use this road in a manner that will not unreasonably interfere with the rights granted hereunder.

It is agreed that the Grantor, at any future time and at its sole expense, may relocate and reconstruct this road; provided that access is still afforded to Grantees' water pump in Lot Twelve (12).

It is further agreed that Right of Way Agreement between the parties, dated January 6, 1958, is hereby terminated.
