GE Homemakers



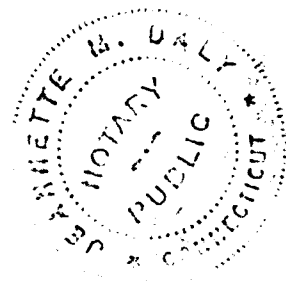

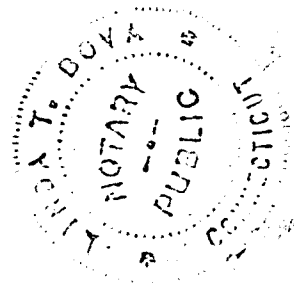
