## AGREEMENT

HICKMAN the use of that certain Well No. 1 located on the Morris Round Lake Ranch which well is more particularly described as being located 1250 feet North and 750 feet East of the South 1/4 corner of Section 6, Township 39, Range 8 E. of the Willamette Meridian in the County of Klamath, for the purpose of an easement to divert and convey water to and upon the property of BENJAMIN J. HICKMAN and CATHERINE F. HICKMAN, husband and wife, known as N½NE½NE½ of Section 7, Township 39, Range 8 E.W.M. described as approximately 8 acres for the purpose of irrigating pasture and a small pond (20'x30'x4').
