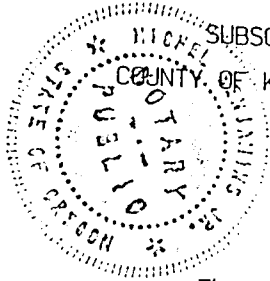
This NOTICE is given that the FREE MAN, (FREE SOVEREIGN)
