KNOW ALL MEN BY THESE PRESENTS, That Comunicept Assembly, an Oregon nonprofit corporation

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by BRAD MEISTER

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Those portions of Block 5 of OREGON PINES as recorded in Klamath County, OR.

The South one-half (1/2) of a portion of Lot 111, more particularly described as follows:

Beginning at the Southwest corner of Lot 75 of Block 5; thence North 03°27'47" West, along the westerly line of Lots 75 and 77, 445.21 feet to the northwesterly corner of Lot 77; thence South 80°18'09" West, 168.52 feet to the easterly right of way line of Nagel-Ridge Way; thence southerly, along the easterly right of way line, along a curve, concave to the South-west, having a radius of 330.00 feet (the chord bears South 11°42'32" West, 131.99 feet) 132.89 feet; thence South 23°14'42" West, continuing along said easterly right of way line 263.67 feet; thence South 82°10'35" East, 326.90 feet to the Southwest corner of Lot 75 and the point of beginning.
