

KNOW ALL MEN BY THESE PRESENTS, that I, CLARENCE WESLEY BYERS, a citizen-freeholder, by right of birth on: April 15, 1926 within and on the lands and/or territories protected by the Constitution of the Union of States of the United States of America, bound by God, in Law, binding upon my past, this day, for all time (forever) and no other, do now, knowingly, depose and state the following:

STATEMENT OF FACTS

From the Holy Bible, King James version:

St. Matthew 24:4 And Jesus answered and said unto them, "Take heed that no man deceive you".
Revelation 18:4 And I heard another voice from heaven, saying, "Come out of her, my people, that ye be not partakers of her sins, and that ye receive not of her plagues".

WHEREAS; SOCIAL SECURITY under USCA Title 42 is a VOLUNTARY INSURANCE which identifies persons by a Social Security policy number and not by parental given name(s), which suborns me, through deception, cloak and color of law, into the jurisdiction of USCA Title 26 and the Law(s) of Nations pursuant to the Limited Liability Act of 1851; and, thus, places the individual under the Law(s) of Nations and the "all controlling" Limited Liability Act(s) disguised as law(s). Those who accept and maintain such a policy number are placed into what is now understood as Article III Jurisdiction with Maritime and Admiralty implication(s).

SPECIFICALLY, at the federal Governmental levels, this deception is noted in USCA Title 42, "The Public Health and Welfare" [and the other federal code titles which are known as the "Negative Law(s)"]. The controlling federal codes are so construed by the State(s) as to mandate their authority over the individual and family by and through intimidation, threat, and invasion of privacy all for the purpose and inescapable result of manifesting itself as the absolute authority. The assumption is that those who join(ed) under the Social Security System submit themselves into the authority vested in the State(s) to operate under fiction(s) of law, and into servitude for the perpetual succession of a force of people for the discharge of debt(s) / insurance premiums.

WHEREAS; without informed consent, through Social Security, I was and am defrauded, extorted, and cheated of my Right(s) of Responsibility, as guaranteed in the Bill of Rights, pursuant to and under Article 1 Section 10, as it also pertains to the Common Law contractual agreements, to-wit: NO STATE SHALL-----OR PASS ANY LAW IMPAIRING THE OBLIGATION OF CONTRACTS clause in the United States Constitution, The Declaration of Independence, and the immunities and protections therein by inherent right.

HENCEFORTH; it is now known, understood, clear and certain through my careful research and study of the law(s) that the Social Security System and policy number(s) has by definite design become a tool to accomplish ends wholly beyond the sphere marked out by the United States Constitution as a stealthy encroachment on and an easy way for breaking down the limitation(s) and guarantee(s) of protection against aggression, feudalism, usurpation; and,

THEREFORE; Social Security, by its design and effect to insure a perpetual force of people misled, is recognized as an insurance policy and certificate of authority and does so through the federal Constitution. Thus, guaranteeing to the federal form of Governments and the insurance of debts to the Nations of the World, their perpetual succession for the payment of premiums of insurance for debt(s) secured by the Federal Reserve under the TONTINE Insurance Doctrine.

THIS form of control and discovery of the federal Constitution is to be found upon our land under Amendments eleven (11) through twenty-six (26) and as per Limited Liability and Jurisdiction of titles which result in the relinquishing of the Rights of Responsibility of those who are still deceived thereunder, to-wit: USCA Title 2, 7, 8, 11, 12, 15, 16, 19, 20, 21, 22, 24, 25, 27, 29, 30, 31, 33, 36, 40, 41, 42, 43, 45, 46, 47, 48, 49, and 50: and it is recognized that the insurance policy(ies) which is/are collective [collectors] of federal USCA Titles are pursuant to Title 26 of the Internal Revenue Code, Law(s) of Nations, and/or the Limited Liability acts since and including that of 1851.

REVOCATION

THEREFORE, Let it be known that I, CLARENCE WESLEY BYERS, having been duped, deceived, and misled by the(se) device(s) and cloak(s) of Government(s), do hereby REVOKE AND CANCEL the SOCIAL SECURITY Insurance policy and Certificate of Authority number known as:

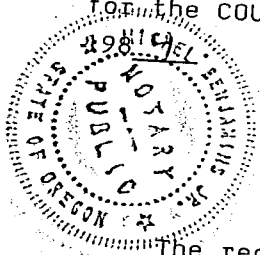
