A hearing was held on this matter on March 15, 1984, pursuant to notice given in conformity with Ordinance No. 45.2, Klamath County, before the Klamath County Hearings Officer, Jim Spindor. The applicant was present. The Klamath County Planning Department was represented by Jonathan Chudnoff. The Hearings Reporter was Karen Alberto.

The hearing was then closed, and based upon the evidence submitted at the hearing, the Hearings Officer made the following Conclusions of Law:

## CONCLUSIONS OF LAW:

- 1. The proposed use is conditionally permitted within the zone within which it is proposed to be located.
  - 2. The location, size, design and operating characteristics

1 of the proposed use are in conformance with the Klamath County 2 Comprehensive Plan.

- 3. The location, size, design and operating characteristics 3 4 of the proposed development will be compatible with and will not 5 have significant adverse affects on the appropriate development  $\boldsymbol{6}$  and use of abutting property owners and the surrounding neighbor-
  - The granting of this Conditional Use Permit is consistent with the goals of the LCDC.
  - 5. The granting of this Conditional Use Permit is subject to the following conditions:
- 12 a. The applicant shall follow the plot plan as set forth 13 on Exhibit B. 14
- b. The mobile home in question shall be limited to occupancy 15 by family members and/or foster children.
  - The mobile home shall be landscaped to fit in with the surrounding area.
  - d. The applicant shall follow the plan which he has submitted to Ray Bidegary, Director of Public Works, City of Klamath Falls, as set forth in Exhibit F.

The requested use has been granted with conditions based on the following findings of fact:

- 1. The applicant makes this request to allow a mobile home for residential use. The applicant operates a foster care home, and he and his wife would sleep in the mobile home while the foster children would use the main house.
